## NOTES FROM THE CHAIR

I am delighted that Dr. David Mladenoff, from the Department of Forest Ecology & Management at the University of Wisconsin-Madison, has been appointed as the new editor of *Landscape Ecology*. The US-IALE Executive Committee is fully confident that David will build on the successful foundation established by past editors Robert Gardner and Frank Golley, and will make increasingly important contributions to the scientific literature of landscape ecology.

Recently, the US-IALE Executive Committee decided to turn over the processing of journal subscriptions to the publisher Kluwer. There were several reasons for this decision. The previous system of passing journal subscriptions through US-IALE complicated the logistics, and resulted in numerous delays and problems. The pass through also produced an extraordinary workload on the US-IALE Treasurer. The new system should be more efficient. Unfortunately, the change eliminated the US-IALE's opportunity to offer a reduced subscription rate for students. The Executive Committee is currently investigating other means of subsidizing student participation in US-IALE, including reduced dues and symposium fees.

We are working to update and expand our web site, thanks to volunteer Ramesh Sivanpillai of Texas A & M University. Please contact him directly with any suggestions or contributions at: r0s6971@acs.tamu.edu.

I am pleased to report that US-IALE has received official tax-exempt status from the U.S. Internal Revenue Service. Special thanks for this long-term effort by Jeffrey Klopatek, Charlotte Pyle, and current Treasurer Phil Townsend.

We are continuing work on Phase Two of our strategic plan. The Phase 2 Strategic Planning Committee, chaired by Alan Johnson, is working on recommendations made by the previous committee. The committee will present a report at this year's annual symposium in April. At the upcoming symposium in Ft. Lauderdale, elections will be held for Chair, two Councilors-At-Large, and one Student Representative. Nominations are now open for all of these positions. The importance of these positions to the future growth and evolution of US-IALE cannot be over-estimated.

We are currently seeking a suitable site for the 2002 US-IALE symposium.

The organizational model used by US-IALE involves discrete positions for Local Host and Program Chair. This system reduces the workload and responsibilities of each position. In addition, over the past years US-IALE has accumulated a wealth of expertise and information concerning symposium organization and administration. When you are renewing your US-IALE dues, please consider making contributions to the US-IALE Foreign Scholar Award and the Student Travel Award. Our annual dues are very modest, but with your support for these awards we are able to assist foreign and domestic scholars to participate in our annual symposia. #### **US-IALE 2000 –ANNUAL MEETING Fred Sklar**

The 15th Annual Symposium of the U.S. Chapter of the International Association for Landscape Ecology will be held April 15-19, 2000, at the Marina Marriott in Fort Lauderdale, Florida. The theme of this year's symposium is **Integration of Societal and Landscape Heterogeneity: Problems and**

**Solutions.** The abstract deadline is 2 February 2000, and the pre-registration deadline is 17 March 2000. Visit the web (<http://www.ces.fau.edu/iale2000>) for registration information, information for developing special sessions or workshops, fieldtrips, travel or hotel arrangements, and local tour attractions.

Societal demands for housing, roads, natural resources and jobs are often at odds with demands for parks, clean air & water, nature preserves, and the sustainability of healthy ecosystems. How have these conflicting demands altered landscape heterogeneity? How does landscape heterogeneity affect biodiversity and the quality of life? The IALE-2000 program will carry particular emphasis on: 1. **The Processes and Consequences of Landscape Fragmentation and Alteration** (e.g., fractals, gap analysis, energy flow, climate change, fire effects, percolation, gradients, biodiversity, and regional planning); 2. **Principles of Landscape Management and Restoration** (e.g., biogeography, restoration concepts, biogeochemical budgets & processes, resource management & policy, urban planning, landscape architecture, case studies); 3. **Comparative Systems Analyses** (e.g., scale, landscape function & structure, cityscapes, seascapes, feedbacks & linkages, paleoecology, network analysis, modeling); 4. **Value and Assessment of Landscapes** (e.g., social trends, risk assessment, ecological economics, GIS techniques, mapping, remote sensing).

Hotel accommodations will be in the luxurious Marina Marriott, with easy access to beaches, museums, and a wide range of restaurants. Located on the Intercoastal Waterway, the Marina Marriott is also a stop for The Water Taxi, which is the preferred way to see

the "Venice of America". For the conference, a block of hotel and lodge rooms has been reserved at discounted rates (\$89 per night single to quad occupancy). Conference rates apply during April 15-19 and, on a space available basis, for three days before and after the Conference

## **FOREIGN SCHOLAR TRAVEL AWARD**

The United States Regional Association of the International Association for Landscape Ecology (US-IALE) has a program to support attendance at the annual meeting by landscape ecologists from foreign countries. This year, the 15th annual meeting of US-IALE will be held in Fort Lauderdale, Florida, on April 15-19, 2000. The recipient of the Foreign Scholar Travel Award (FSTA) will receive a personal check from US-IALE

for \$600 U.S. to reimburse meeting attendance costs. In addition, the recipient's registration fees will be waived for the meeting. Because the award is presented at the annual meeting, it is the recipient's responsibility to cover all transportation and lodging costs associated with participating in the meeting.

**Selection criteria** include the following. (1) Previous recipients of US-IALE Foreign Scholar Travel Awards are ineligible. (2) Applicants must not be U.S. citizens or reside in the United States. Foreign students studying in the United States are ineligible to apply. (3) Recipients must give a paper or poster presentation at the Conference on their research in landscape ecology. We will favor applicants who demonstrate that their research (i) advances the scientific basis of landscape ecology, and/or (ii) the application of landscape ecology for natural resource protection or management. Both new and established landscape ecologists are encouraged to apply. (4) Applications from citizens of G7 countries (France, US, Britain, Germany, Japan, Italy, Canada) will not be accepted. (5) Applicants must have demonstrated financial need and show that without FTSA support, they would not be able to attend the Conference. (6) Applicants must demonstrate that attending the US IALE Conference will represent a significant professional opportunity for developing their expertise in landscape ecology and establishing working relationships with landscape ecologists from other countries.

To apply, the following information should be **submitted by 1 March 2000**: (1) Name; (2) Institution; (3) Email address; (4) Postal Address; (5)

Citizenship; (6) Curriculum vitae; (7) Title, abstract, and 500 word (max) summary (in English) of the paper or poster you will present at the Conference - be sure to explain how your research extends the scientific basis or application of landscape ecology; (8) A statement on what you hope to gain from attending the US-IALE Conference (no more than 500 words, in English) and explanation of why you need financial assistance to attend the conference. ## NEW SUBSCRIPTION PROCESS FOR LANDSCAPE ECOLOGY

Effectively immediately, US-IALE will no longer process subscriptions to *Landscape Ecology* or handle renewals

for the journal. For issues related to the journal, members will now deal directly with Kluwer Academic Publishing. This forms a direct line of contact between the publisher and subscriber and also allows subscriptions to be charged directly to credit cards. Directions for subscribing to the journal are found on Kluwer's *Landscape Ecology* webpage ([www.wkap.nl/journalhome.htm/0921-2973](http://www.wkap.nl/journalhome.htm/0921-2973)). Note that to receive the IALE member discount, you must first renew your membership with US-IALE. Your receipt from US-IALE will include your US-IALE member number. **Provide your member number to Kluwer when you subscribe to the journal.** US-IALE will transmit the names and member numbers of active members to Kluwer so that they can finalize your subscription. Also, if you subscribe to *Landscape Ecology*, you will note that the price of the journal has increased. However, the number of issues and pages published per year is scheduled to increase significantly this year as well.

### 2001 US-IALE MEETING First Announcement

The 16<sup>th</sup> annual symposium of the U.S. Chapter of the International Association for Landscape Ecology will be held on April 25-29, 2001, in the Memorial Union on the campus of Arizona State University, Tempe, AZ. The theme for this symposium will be: **Pattern, Process, Scale, and Hierarchy: Interactions in Human-Dominated and Natural Landscapes.**

A major goal of landscape ecology is to understand the interactions between spatial pattern and ecological processes, the role of scale, and hierarchical linkages in heterogeneous landscapes

that are increasingly shaped by human activities. This understanding will be essential not only for unraveling how nature works, but also for developing a harmonious relationship between humanity and nature. In the past two decades, landscape ecologists have addressed various aspects of this goal through numerous theoretical and empirical studies. As we embark on a new stage of landscape ecology in the 21st century, it is important to reflect on the advances that have been made and to identify new directions that must be taken toward this goal. Therefore, the theme of the 2001 US-IALE Symposium will be understanding the interactions among pattern, process, scale, and hierarchy in human-dominated and natural landscapes, with a special emphasis on landscapes that have been profoundly modified by humans – the urban environment.

The symposium will focus on the following topics: (1) What do we know about the relationships among pattern, process, scale, and hierarchy, and how do these relationships differ between natural and human-dominated landscapes? (2) How do spatial heterogeneity and hierarchical structure affect the translation of information across scales in different landscapes, or how do we scale up pattern and process in heterogeneous landscapes? (3) How can theory and principles on pattern-process interactions, scaling, and hierarchy be applied to landscape management, landscape architecture, urban planning, and nature conservation? (4) What new technologies and methods are available for facilitating our study of the relationship among pattern, process, scale, and hierarchy, and how? (5) What role does long-term ecological research play in landscape ecology, and what

have we learned from the existing urban LTER studies? (6) How can natural and social sciences be more effectively integrated into landscape ecology? How can the ongoing discussion of the relationship between culture and nature influence the development of theory and practice in landscape ecology? (7) How can we effectively integrate landscape ecology with the design and planning of landscapes? What is the significance of the relationship between urbanism and landscape ecology? We encourage the submission of proposals for organizing special symposia and workshops on the above topics of emphasis, and also welcome presentations on other topics that are relevant to landscape ecology.
